Deposit shall be credited to the first month's moorage when assigned. I also understand that I will be charged an annual fee to retain my space on the wait list in the amount of TWENTY FIVE (\$25.00) DOLLARS due January 1st of each year. Any account where the annual fee is not paid by March 31st, deposit will be presumed forfeited and the name will be removed from the list.
