 Puget Sound Regional Council's Regional Competition for 2027-2028 Federal Transportation Funding and Kitsap Regional Coordinating Council's 2024 Call for Projects for the Kitsap Countywide Competition

Arne Bakker, Chief Operations Officer, explained the Port would be seeking funding from the PSRC Regional and KRCC Countywide competitions for Phase 2.2 of Airport Way, formerly known as the Cross-SKIA Connector. He provided history on the completion of Phases 1 and 2.1 of the road project detailing that Phase 2.2 construction consists of approximately 3,800 linear feet of road with a project cost estimate of \$3,694,900.

Mr. Bakker provided timelines for the funding competitions highlighting the Port's next steps. He spoke to the eligibility requirements for the competitions and responded to questions and comments from the Board

- Described Puget Sound Regional Council's (PSRC) new transportation dashboard which is on their website.
- Discussed PSRC's upcoming review of regional Manufacturing/Industrial Center designations.
